

## CITI Research Compliance Training

### Registration Instructions

: Go to [www.citiprogram.org](http://www.citiprogram.org) and click on the "Registered" button located next to the blue login box to the right of the homepage.

The next steps are numbered 1-7. These steps will collect information to register your account and place you in the correct course based on JU's settings.

Step 1	<ul style="list-style-type: none"> <li>- Enter "Jacksonville University" in the "Select Your Organization Affiliation" search box.</li> <li>- Click the box to "Agree to the Terms of Service".</li> <li>- Click "Continue to create your CITI username/password".</li> </ul>
Step 2	<ul style="list-style-type: none"> <li>- Enter your information in the appropriate boxes about using your official JU email address as the primary email. You can include a personal email as the secondary option.</li> <li>- Click "Continue to Step 3".</li> </ul>
Step 3	<ul style="list-style-type: none"> <li>- JU uses a Single Sign On feature for TFC. You may login using your JU user ID and password.</li> <li>- Select a security question and answer.</li> <li>- Click "Continue to Step 4".</li> </ul>
Step 4	<ul style="list-style-type: none"> <li>- This step collects demographic information. Only the boxes with the red asterisk are required.</li> <li>- Click "Continue to Step 5".</li> </ul>
Step 5	<ul style="list-style-type: none"> <li>- JU's Office of Research does not require that you maintain CE Credits; however, if you choose "Yes" as your answer, you will have the ability to request and personally pay for those credits at a later date if you decide you need them. Choosing "Yes" does not obligate you in any way, it only makes them accessible to you.</li> <li>- You may choose to allow CITI Program to contact you to participate in a research survey or for marketing information, but a "Yes" answer is not required by JU.</li> <li>- Click "Continue to Step 6".</li> </ul>
Step 6	<ul style="list-style-type: none"> <li>- Fill in the required answers to "Institutional email address" and Department and select the appropriate "Role in human subjects research" using the drop</li> </ul>

down button. FYI – These fields are a template of CITI, so please NOT put an Employee number as JU does not require it.

- Click “Continue to Step 7”.

**NEW CITI Learner Registration**

1. For the basic Human Subjects Research modules, select the first option:  
*“Yes, I conduct research with live human beings, human samples or with data derived from human beings.”*

- Click Next.

2. “Human Subjects Research (HSR) Training – IRB Select the type of research training required based on your learner group

*[Conduct of basic, applied, and/or translational research that aims to contribute to the body of knowledge in the field of health and medicine.]*
